3.4 Level 3 Construction Technology (L3CTN) class

Members reviewed the Technology Department proposal to undertake a construction project in Te Ramanui courtyard. Project will involve four Year 12 students and 12 Year 13s. R Williams confirmed the Year 12s have the capability to take over if all Year 13s left.

The Board agreed on a \$10K budget (from Operations - Curriculum budget) with a \$5K contingency. It was further recommended external sponsors be sourced to reduce costs.

Noted, the ability to transport and sustainability of timber was queried. Sound test checks have been requested to determine material suitability.

- (e) and (f) remove wording 'as selected by lwi.' Be explicit and name the two Trusts.

Below (g) tidy with election result being declared - use official wording.

Bottom page 47 of pack. Last line - correct word spelling and remove the word cultural, correct spelling of kaitiakitanga.

The Ministry will put the Constitution out for consultation however it was suggested the Ministry also provide advice to the community that the Establishment Board will remain in place until early next year at which time it will transfer to a newly elected board.

Upcoming Election - need to notify both Trusts 30-60 days prior to the election so they pre-select their representative. Remind them when nominations are announced. Include in board election procedures together with clarification as to what a Trust representative is, i.e., full board member with all responsibilities of a board member.

New Board established May 2024 - first day of the new term of the new board, all finances should be closed off (but not signed off). Officers from previous board can sign off documents. Mandate to be out by 1 June 2024.
