3. Decisions and Discussions

3.1 South Road Building Project

Background was provided regarding the history of the South Road property and more recently, growth within the Alt Ed program, namely the integration of the Ko Wai Au? program and how limitations of the space have become more apparent. BF Sullivan Contracting and Ryan Campbell have reviewed the property and structure providing options as to how the house can be adapted to be fit for purpose. The Ministry have confirmed Te Paepae o Aotea have overall control of the project.

The benefits of an off-site facility were discussed specifically as a means to cater to those students requiring an alternate schooling solution and as a flexible facility to run short courses etc. e.g., staff first aid, meetings, etc. Members discussed the work required to maintain building fitness and compliance, i.e., accessibility, fire, bathroom. An alternate suggestion to forego a remodel and undertake an upgrade of the house to maintain compliance was mooted however members agreed the need for an alternate schooling solution will always be there. Other advantages to a remodel include property privacy, ownership and the site's ongoing potential. The project can be financed through general funds.

Discussion pivoted to the proposed plan options. Pricing estimates to be sought for the two options. R Williams to disseminate on receipt for members to review and if required, call a specialist property meeting to discuss and progress.

7.1 Tumuaki Report

Noted

- Fire Evacuation triggered by students. All evacuated except one student as a health and safety issue. Emergency Services staff advised.
- Harrison Chew have completed initial emergency plans. Will be presenting to staff next week with a separate SLT session. Harrison Chew will return February to run assemblies with students and a drill same day.
- Learning Hub Junior students engaging in health. Year 9s will undertake next week in house. Staff are not confident (focus healthy relationships). J Brewer will take classes from a health perspective. Years 7 & 8 will go through Harold. Years 9 & 10 through their First Aid. Staff are working to come up with a plan. This matter was raised in the Policy meeting.

Policy says consult with the community once every two years. Tablets will be set up and available for parents while waiting to attend interviews.

- Attendance statistics are not anywhere near MoE targets. Attendance document from Ministry shows Y9 are above national level, with Y11 & 12 way down. Nationally not good but across Taranaki, not too terrible. 40% attending school nationally.
- Banking staffing currently in credit. Zero balance required by the crossover in March.
- Three new classroom teachers arriving in the new year. Advertising for the Pastoral Lead position closes tomorrow.
- Staff exits 4/5. All offered exit interviews. Most declined as communication lines have been open over the whole period. One submitted a letter.
- Some international teachers have requested sign off from provisional to full registration. K Surgenor organised the documentation and has undertaken lesson observations and provided subsequent recommendations.

Junior cups/trophies are scaled down so people can see progression through the school. Clear messaging will go out that cups/trophies are not for keeps.

10.5 Potential Board Election Timelines 2024

T Scollard spoke to outstanding requirements to get the alternate constitution passed:

- The Ministry requires confirmation iwi are happy with the proposed alternate governance. This needs to be ready to go once the new Minister of Education is appointed.
- Once passed by the Minister, a timeline of the election process can be put together to ensure the new Board is in place on 2 July 2024. The NZSTA formula is 63 days. If approved in January, the date can be brought forward. Puanga, 30 June 2024 has a special synergy as its in line with the naming of our school.
- The normal school election cycle will be 2025 therefore Te Paepae o Aotea's elected Board would only be in place for one year. A request for dispensation from the Ministry to ensure a 4-year term is required, with a potential split in there for continuity.

Alternate constitution survey - feedback was atypical, both positive and negative responses. This has not altered the submission to the Minister.

Board Elections

- Arrange short information sessions now outlining what it means to be on the board of a new school.
- The NZSTA site has Infowebs that can be used at an information evening, etc.
- Actively shoulder tap people.
- Appoint a Returning Officer.



Alternate Constitution - Formal Request to lwi

W Edwards to provide a formal request to iwi and report response back to the Board.

Board to ensure the briefing to the Minister is tied to the Settlement legislation of the two iwi. The NR Settlement Act of 2004 and the NR Settlement Act of 2014/15 provide robust rationale from a legislative perspective. Ensure a letter from the Board to the Ministry is included. Iwi can reference the Acts as well. This is urgently required.

D Leath's briefing to the Minister is strong however there is uncertainty as to whether it references the Settlement Acts.
